#### **DIRECTOR OF TRANSPORTATION - TRANSPORTATION UPDATE**

The Board welcomed Director Richter to share an update on transportation news around the Division. This year's startup went more smoothly than last year as all routes had drivers for the first day of school. A shortage of spare bus drivers is presenting challenges when drivers are unavailable to complete their routes for personal reasons and several routes have not operated if a driver is temporarily unavailable. Director Richter reported that the funding increase provided for student transportation has addressed some of the pressures that contractors were experiencing, however, inflationary costs continue to be an issue. The Division's driving school has been steadily training drivers and has modified its training program following the removal of MELT requirements in the spring. Received as information only.
