  - Into a Guaranteed Investment Certificate (through Canadian Imperial Bank of Commerce Wood Gundy) a minimum of \$150,000 (one hundred fifty thousand dollars) to a maximum of \$900,000 (nine hundred thousand dollars)
  - Into bonds (through Canadian Imperial Bank of Commerce Wood Gundy) a minimum of \$150,000 (one hundred fifty thousand dollars) to a maximum of \$600,000 (six hundred thousand dollars).
