TRUSTEE/ADMIN INFORMATION ITEMS

Associate Superintendent Moghrabi highlighted that over 150,000 (one hundred and fifty thousand) meals were provided to students at the five schools that were part of the division's nutrition program during the 2020-2021 school. In 2021-2022 over 90,000 (ninety thousand) meals are scheduled. In addition to funding from the provincial government, Northern Lights Public Schools (NLPS) received grants of \$147,000 (one hundred and forty seven thousand dollars) from the Breakfast Club of Canada, \$23,000 (twenty three thousand dollars) from President's Choice Children's Charities and \$1,200 (one thousand two hundred dollars) from APPLE Schools to provide snacks and meals throughout the division. Imperial, Cenovus, TC Energy and the Lac La Biche County Social Committee also have provided funding for the 2021-2022 school year.
